



Who in my family is eligible?

Eligibility is determined by the number of people living in your household, and the total income of all household members. If your household is eligible, all people living in the household would be eligible for the discount.

Does the discount only apply to my primary medical healthcare visits?

The sliding fee discount applies to medical, dental, rehabilitative, and optometry services received at Katahdin Valley Health Center. It is also applied to your prescriptions at the KVHC Pharmacy.

Do I need to fill out a separate sliding fee discount application for specialty services?

No, Katahdin Valley Health Center has one application for all services.

Is there someone I can talk to about the sliding fee discount application, or for assistance with my prescriptions?

Yes, our Patient Assistance team is available five days a week. They are available for a walk-in visit, or you can schedule an appointment at any time by calling 1-866-366-5842 ext. 325.

Sliding Fee Program

FY 2025 KVHC Medical Sliding Fee Schedule

What is the Sliding Fee Program?

Katahdin Valley Health Center offers a sliding fee discount to all eligible patients. You may be eligible for a sliding fee discount even if you have insurance. Enrollment in this program is based on the federal poverty guidelines, which use family income and size to determine the amount of the discount. You can apply for the sliding fee discount at any time during the year. KVHC reviews sliding fee applications annually, beginning April 1st.

How do I apply?

You will need to fill out an application form and provide KVHC with the documentation requested below. KVHC follows all HIPAA regulations and guidelines. Any information provided to KVHC is held to the highest level of confidentiality.

If you filed a 2023 Federal Income Tax return, we are required to have a signed copy, as well as one of the following documents as proof of income. If you did not file income taxes, please submit two of the following documents as proof of income:

- Three recent months of bank statements showing direct deposit of income.
- Annual Social Security Benefit Statement
- Employment paystubs for the last four weeks
- Unemployment Statement
- SNAP or TANF Statement

** Certain items provided within a visit(s) cannot be discounted; these include but are not limited to: Injected Medications, Durable Medical Equipment or Supplies, Physical Therapy Aids, Dentures, Crowns, Bridges, and Mouth Guards. All patients below 100% of the Poverty Guidelines will be charged the nominal fee listed or less based on demonstrated ability to pay. Preventative and additional services performed in the same visit will result in only one nominal fee.

Payments must be made at time of visit.
